# A remark on 2-adjacency relation between Montesinos knots and 2-bridge knots

#### Abstract

We show that for every 2-bridge knot K, there is an infinite family of Montesinos knots  $\{K_q\}$  such that each  $K_q$  is 2-adjacent to K. We also give a new example of 2-adjacency relation between 2-bridge knots.

#### 1 Introduction

Let K and K' be knots in  $S^3$ . K is called *n*-adjacent to K' for some  $n \in \mathbb{N}$ , if K admits a diagram containing n (generalized) crossings such that changing any nonempty subset of them yields a diagram of K' ([1], [5]). In [9], [11], and [12], the author studied *n*-adjacency relation between 2-bridge knots for n = 2, 3 using Dehn surgery techniques in detail. Note that 2-adjacency relation between Montesinos knots is still not determined in general.

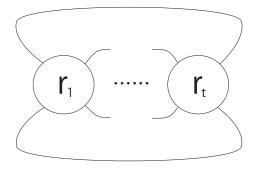


Figure 1: Montesinos knots.

Recall that a Montesinos knot or link  $M((\alpha_1, \beta_1), \ldots, (\alpha_t, \beta_t))$  is defined to be a knot or link connecting t rational tangles of slope from  $r_1 = \frac{\beta_1}{\alpha_1}$  through  $r_t = \frac{\beta_t}{\alpha_t}$  as indicated in Figure 1 ( $\alpha_i$  and  $\beta_i$  are coprime integers). It is well-known that if  $t \leq 2$ , it is a 2-bridge knot or link. For a reference, see [2] and [3].

In [10], the author studied 2-adjacency relation between Montesinos knots and the trivial knot. In the current short note, we show that for every 2-bridge knot K, there is an infinite family of Montesinos knots  $\{K_q\}$  such that each  $K_q$  is 2-adjacent to K, and we also present a new example of 2-adjacency relation between 2-bridge knots.

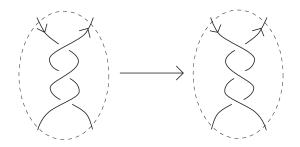


Figure 2: A generalized crossing change of order -3.

## 2 Main Theorem

Let K be an oriented knot, link, or tangle in  $S^3$ . A crossing disk for K is an embedded disk  $D \subset S^3$  such that K intersects int(D) twice with zero algebraic intersection number. The boundary of a crossing disk is called a crossing circle. Then, a generalized crossing change of order  $d \in \mathbb{Z}$  on K is achieved by  $-\frac{1}{d}$ -Dehn surgery on a crossing circle and results in introducing d full twists to K at the crossing disk (see Figure 2). A generalized crossing of order d on a diagram of K is a set C of d twist crossings on two strings that inherit opposite orientations of K. If K' is obtained from K by switching all the crossings in C simultaneously, then K' is the result of a generalized crossing change of order d on K. Note that if |d| = 1, K and K' differ by an ordinary crossing change while if d = 0, then K = K'. Throughout this paper, we assume that  $d \neq 0$ .

Recall that K is 2-adjacent to K', if there are two generalized crossings of order  $d_1$  and  $d_2$  in a diagram of K such that correspondingly, both each generalized crossing change and simultaneous generalized crossing changes yield a diagram of K'.

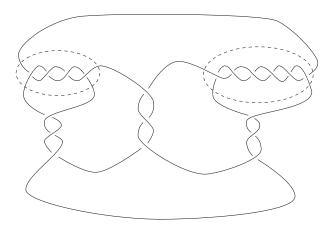


Figure 3:  $MK_{(q,d_1,d_2,\varepsilon_1,\varepsilon_2)} = M((2d_1q + \varepsilon_1, 2d_1), (q, -1), (2d_2q + \varepsilon_2, 2d_2))$ , where  $q = 3, d_1 = 2, d_2 = -3$  and  $\varepsilon_1 = \varepsilon_2 = +1$ .

**Example 1 ([10]).** For an integer q, non-zero integers  $d_1, d_2$  and  $\varepsilon_1 = \pm 1, \varepsilon_2 = \pm 1$ , let  $MK_{(q,d_1,d_2,\varepsilon_1,\varepsilon_2)}$  be the Montesinos knot  $M((2d_1q + \varepsilon_1, 2d_1), (q, -1), (2d_2q + \varepsilon_2, 2d_2))$ (see Figure 3). It is easily observed that the generalized crossings of order  $\varepsilon_1 d_1$  and  $\varepsilon_2 d_2$ in the dotted circles for  $MK_{(q,d_1,d_2,\varepsilon_1,\varepsilon_2)}$  as shown in Figure 3 make  $MK_{(q,d_1,d_2,\varepsilon_1,\varepsilon_2)}$ 2-adjacent to the trivial knot.

**Lemma 2.** Suppose  $r = \frac{2dn^2}{2dmn + \varepsilon}$  for some coprime integers m, n, a non-zero integer d and  $\varepsilon = \pm 1$ . Further, for  $\frac{n}{m} = [a_0, a_1, \dots, a_k] = a_0 + \frac{1}{a_1 + \dots + \frac{1}{a_k}}$ , if k is odd (resp. even), let  $\epsilon = 1$  (resp. -1). Then, a rational tangle of slope  $\frac{0}{1}$  is obtained from a rational tangle of slope r by a generalized crossing change of order  $\epsilon \varepsilon d$ .

**Proof of Lemma 2.** The denominator and the numerator of the rational tangle of slope r are a 2-bridge knot and a 2-bridge link with unknotting and unlinking number one by a generalized crossing change, respectively. Then, the statement is contained in the works of Kanenobu–Murakami [6] and Kohn [7]. See, also [8]. In fact, if  $\frac{n}{m} = [a_0, \ldots, a_k]$ , then we have  $\frac{2dn^2}{2dmn + \varepsilon} = [a_0, \ldots, a_k, 2\varepsilon d, -a_k, \ldots, -a_0]$  if k is odd or  $[a_0, \ldots, a_k, -2\varepsilon d, -a_k, \ldots, -a_0]$  if k is even.

We also need the following lemma by Ernst–Sumners [4].

Lemma 3 ([4, Lemma 2.1]). A Montesinos knot or link  $M((\alpha_1, \beta_1), (\alpha_2, \beta_2))$  is

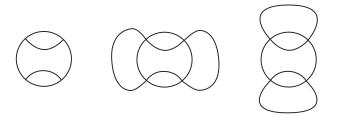


Figure 4: The rational tangle of slope  $\frac{0}{1}$ , its denominator and numerator.

isotopic to a 2-bridge knot or link  $M((x\alpha_2 + y\beta_2, \alpha_1\beta_2 + \beta_1\alpha_2))$ , where x and y are any integers such that  $\alpha_1 x - \beta_1 y = 1$ .

We generalize Example 1 as follows.

**Theorem 4.** For coprime integers m, n, non-zero integers  $d_1, d_2$  and  $\varepsilon_1 = \pm 1, \varepsilon_2 = \pm 1$ , a Montesinos knot or link  $M((2d_1mn + \varepsilon_1, 2d_1n^2), (m, -n), (2d_2mn + \varepsilon_2, 2d_2n^2))$  is 2-adjacent to a 2-bridge knot or link M((m, -n)) by two generalized crossing changes of order  $\epsilon_1 \varepsilon_1 d_1$  and  $\epsilon_2 \varepsilon_2 d_2$ , where  $\epsilon_i = \pm 1$  are as in Lemma 2.

**Corollary 5.** For every 2-bridge knot K and fixed non-zero integers  $d_1, d_2$ , there is an infinite family of Montesinos knots  $\{K_q\}$  such that each  $K_q$  is 2-adjacent to Kby two generalized crossing changes of order  $d_1$  and  $d_2$ .

**Proof of Corollary 5.** For an integer q, M((m+nq, -n)) is isotopic to M((m, -n)). Hence, unless n = 0, we can easily construct a family  $\{K_q\}$  by Theorem 4 as desired.

By putting m = 1, we also have the following new example of 2-adjacency relation between 2-bridge knots or links.

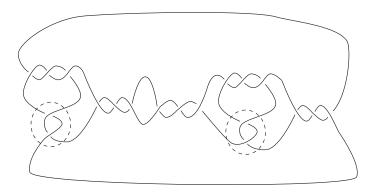


Figure 5: The 2-bridge knot M((7, 18), (1, -3), (7, 18)) is 2-adjacent to the 2-bridge knot M((1, -3)), here  $\frac{18}{7} = [3, -2, -3]$  ( $\epsilon_1 = \epsilon_2 = -1$ ).

**Corollary 6.** A 2-bridge knot or link  $M((2d_1n + \varepsilon_1, 2d_1n^2), (1, -n), (2d_2n + \varepsilon_2, 2d_2n^2))$  is 2-adjacent to a 2-bridge knot or link M((1, -n)) by two generalized crossing changes of order  $\epsilon_1\varepsilon_1d_1$  and  $\epsilon_2\varepsilon_2d_2$  (for the case  $d_1 = d_2 = \varepsilon_1 = \varepsilon_2 = 1$  and n = 3, see Figure 5).

**Remark 7.** In [11], we proved that if a 2-bridge knot or link M((m,n)) is 2adjacent to a 2-bridge knot or link M((m',n')), then n is divisible by n', and conjectured that if a 2-bridge knot K is 2-adjacent to a 2-bridge knot  $K'(\neq K)$  by two generalized crossing changes of order  $d_1$ ,  $d_2$ , then  $K = M((\alpha, \beta))$ , where  $\frac{\alpha}{\beta} = [2d_1, 2d_2]$

or  $[2d_2, 2d_1]$  in Conway's notation, and K' is the trivial knot. Therefore, Corollary 6 gives a counterexample to the conjecture of 2-adjacency relation between 2-bridge knots.

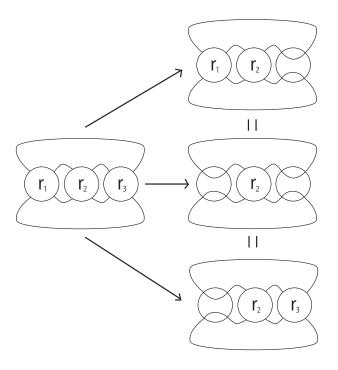


Figure 6: A Montesinos knot or link 2-adjacent to a 2-bridge knot or link.

**Proof of Theorem 4.** By Lemma 2, it is easy to see that M((m, -n)) is obtained from  $M((2d_1mn + \varepsilon_1, 2d_1n^2), (m, -n), (2d_2mn + \varepsilon_2, 2d_2n^2))$  by simultaneous generalized crossing changes of order  $\epsilon_1\varepsilon_1d_1$  and  $\epsilon_2\varepsilon_2d_2$ . Thus, it is sufficient to show that  $M((2d_1mn + \varepsilon_1, 2d_1n^2), (m, -n))$  and  $M((m, -n), (2d_2mn + \varepsilon_2, 2d_2n^2))$  are isotopic to M((m, -n)), respectively (Figure 6). If we put  $x = -2d_1mn + \varepsilon_1$  and  $y = -2d_1m^2$ , then we have  $(2d_1mn + \varepsilon_1)x - (2d_1n^2)y = 1$  and  $xm + y(-n) = \varepsilon_1m$ . Therefore, by Lemma 3, we can conclude that  $M((2d_1mn + \varepsilon_1, 2d_1n^2), (m, -n))$  is isotopic to  $M((\varepsilon_1m, -\varepsilon_1n)) = M((m, -n))$ . The proof of another isotopic case is quite similar. This completes the proof.
